Behavior-Cognitive Parent Training Model for Special Needs Populations

Course Descriptions: Parent training/counseling is a common service available for parents of children with special needs. There is a long history of behavior-based parent training models. In more recent years, the cognitive model of parent training and counseling have also been put forth and are gaining positive momentum. This workshop will provide a model of parent training that combines the core principles of applied behavior analysis and cognitive-behavior therapy. Those versed in the behavior model or who have attended a behavior-based parent training workshop should only attend Part 2.

Participants will be instructed in how to apply these models within the context of parent training. Specific case examples and scenarios will be presented to emphasize key concepts and strategies. Different strategies to better ensure parent follow through will also be reviewed.
